**22.3 Ratification of the amendment in the clause 6 of chapter-5 of Academic Ordinance.**

The members considered the action taken by the Vice Chancellor in approving the following amendment which was introduced in the clause 6 of the Chapter 5 of the Academic Ordinance-2022 governing the Criteria for Passing courses and Promotion to the next year. The following amendments are applicable from the academic session 2024-25 on the batches who get admitted during the academic session 2024-25.

**Applicability of these amendments:**

1. To all the programmes except those programmes where-in the concerned statutory council/body has prescribed specific norms for passing in individual courses and aggregate and promotion to the next year.
2. To all the programmes being introduced under FYUP scheme as per the provisions of NEP-2020.

The Vice Chancellor apprised the present system of dissemination of information for the students.
