

AC 16.3 Ratification of the approval of the new programmes and curriculum & syllabi of these new programmes effective from the session 2019-20.

The members were apprised about the introduction of following new degree level programmes in Computer Science & Engineering from the academic session 2019-20. Given the rise of the AI professionals, the need was felt to introduce the unique curated programmes focusing on Artificial Intelligence, Machine Learning and Deep Learning at the undergraduate level. Keeping this in view, the proposal from the Principal-CCSIT was submitted to the Vice Chancellor who considered and accorded his approval in anticipation of the consideration of the Council. Further, the recommendations of the Board of Faculty-Engineering on curriculum design and syllabi for these programmes given by the Board of Studies (Computer Science) were discussed by the members. Prof R.K. Gupta queried about the concept of the credits being assigned which was then explained by Prof R.K. Dwivedi. Vice Chancellor mentioned about the need to make amendments in the Academic Ordinance so as to support the new curriculum as it was proposed to be on CBCS system. He requested Pro Vice Chancellor to review the core courses. As there were no structural changes in the study and evaluation scheme of the First year of these programmes, the syllabi and study & evaluation scheme for the First year of these programmes were approved. However, the Council advised and authorized the Vice Chancellor to review the entire curriculum and study & evaluation scheme of these programmes in totality.

AC 16.4 Approval of the revision in the curriculum and syllabi of the existing programmes effective from session 2019-20.

The proposals from different colleges for the consideration of the Academic Council in approving the revision in syllabi and curriculum in line with CBCS, of various programmes of study being offered by the colleges/departments of the University were placed before the Council for its consideration. The members discussed the proposals in detail and decided that the study & evaluation scheme and syllabi of the following programmes be reviewed by the Pro Vice Chancellor and authorized Vice Chancellor to approve on the basis of the recommendations/comments from Pro Vice Chancellor. During the discussions in case of study & evaluation scheme for Pharmacy programmes, Principal-Pharmacy proposed to amend the minimum requirements of overall aggregate marks in D.Pharm programme for the award of Diploma and provision of improvement exam in case of Internal Assessment. The Council advised the Vice Chancellor to constitute a committee review the requirements pertaining to amendments in evaluation and other requirements for the completion of various programmes under Pharmacy Discipline. During the discussion on syllabi of B.Sc. Agriculture programme, Dr. M.P. Singh proposed for the Honors degree in B.Sc. Agriculture in accordance with the norms of Indian Council of Agricultural Research. The members had the consensus over his proposal.

Regulations, 2008. But in accordance with the UGC Gazette notification no. F.5-1/2013 (CPP-II) dated July 05, 2014, Pharm.D degree is a Master's level degree where-in it cannot be treated as Doctoral. The matter was discussed and the Council advised to follow the guidelines of UGC and take further follow-up with UGC on the matter.

RESOLVED THAT THE DATES FOR THE ISSUE OF DEGREES AS ABOVE BE FIXED.


AC 16.16 To consider holding the 5th Convocation of the University.
