



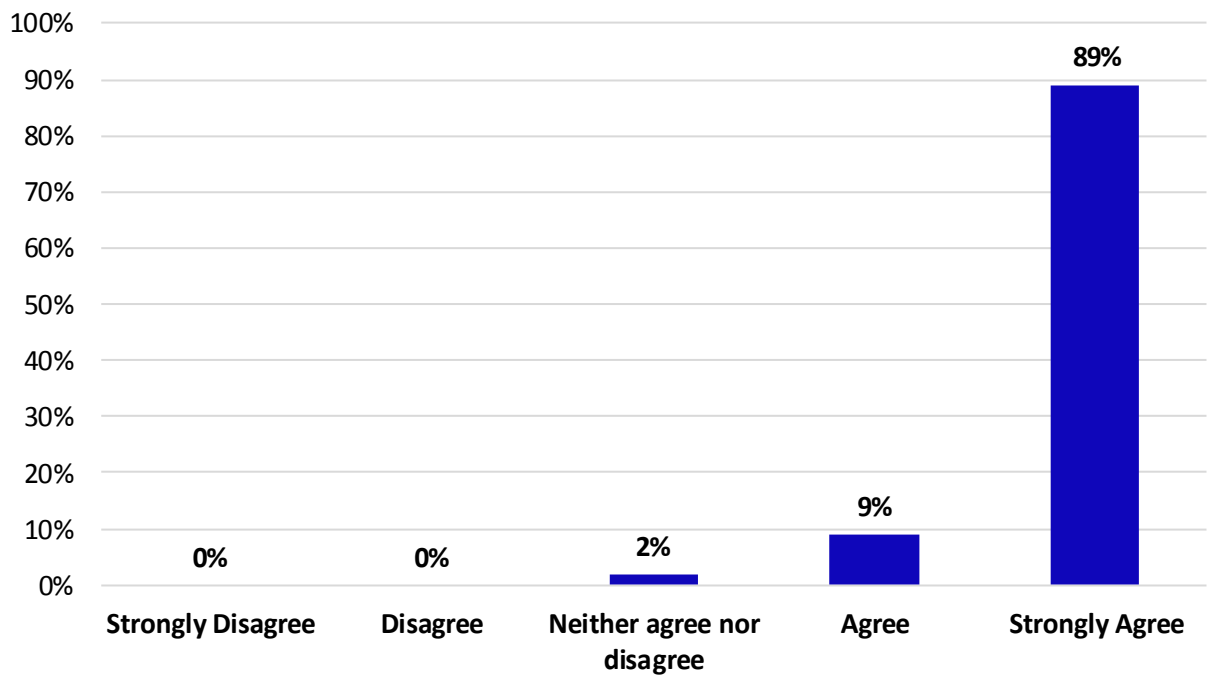

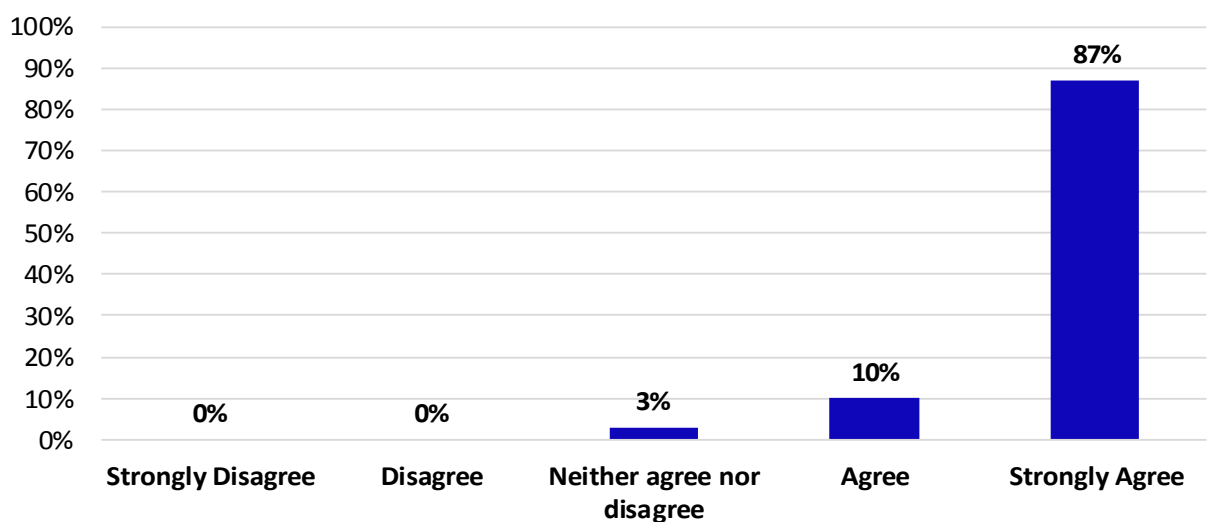

Q1. Aims and Objectives of the syllabus are well defined and clear to teachers.



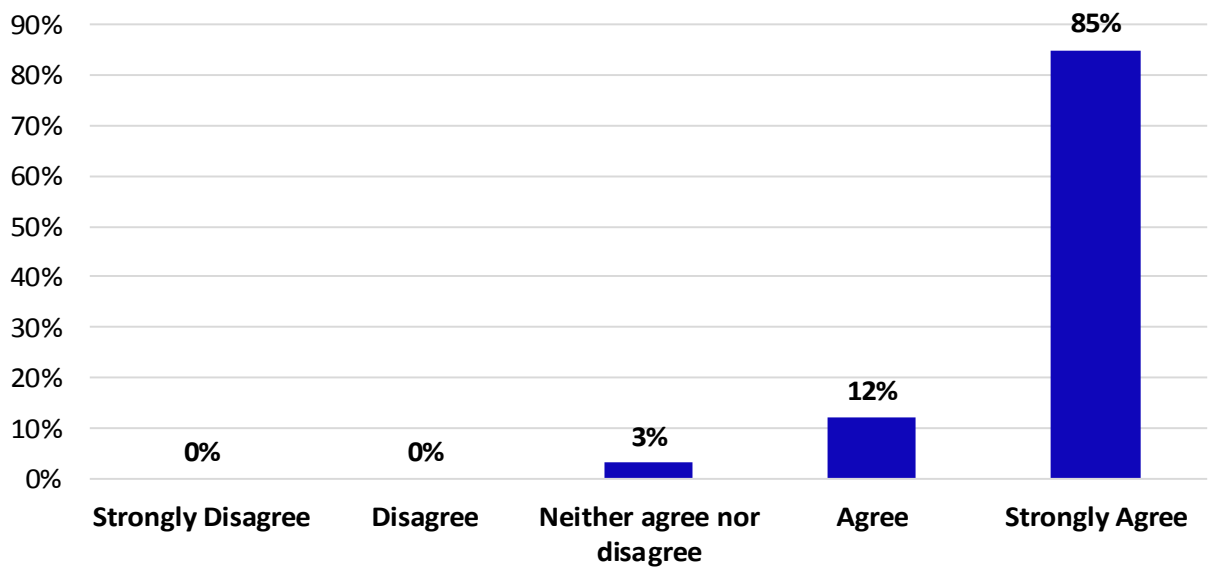

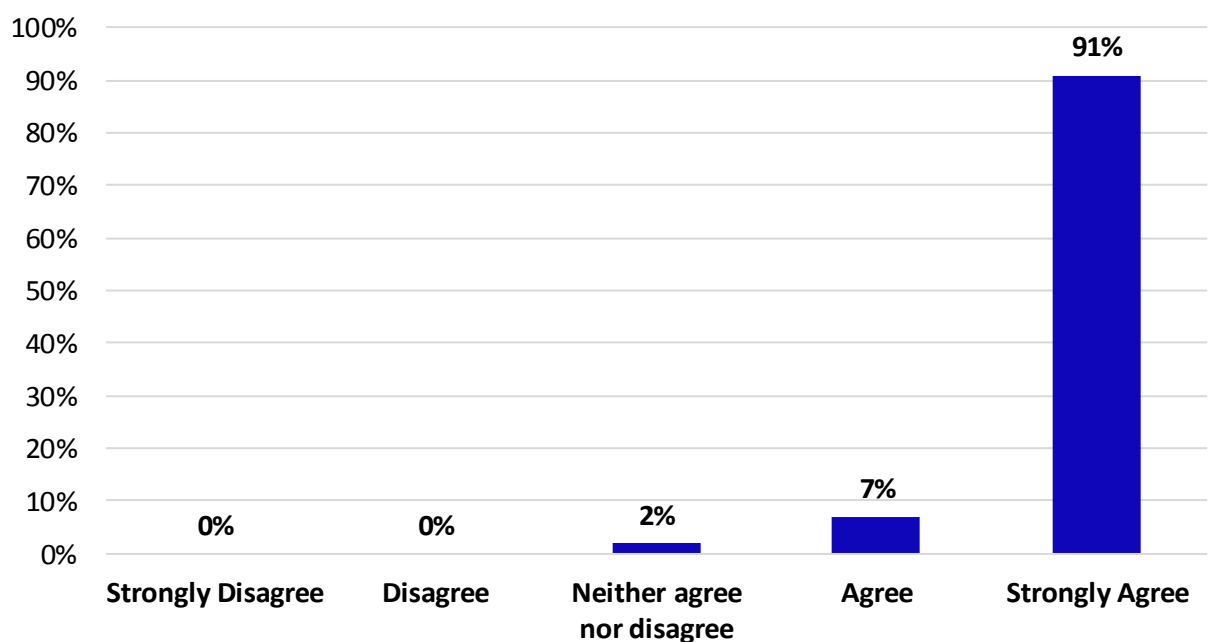

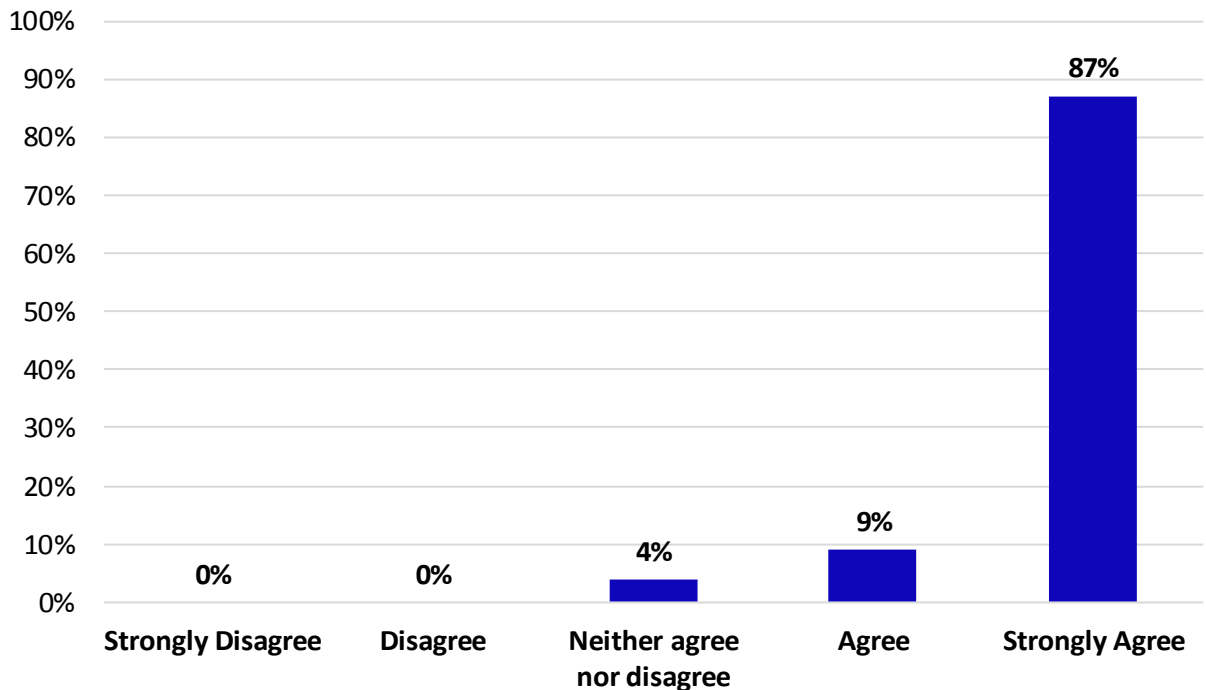

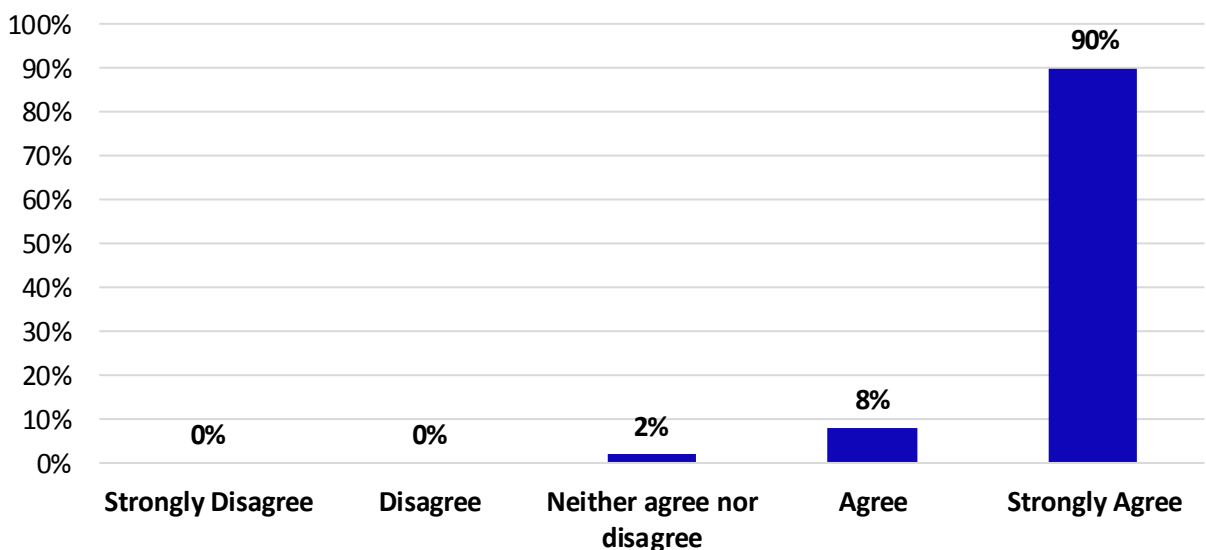

Q5. Extent of effort required by the students.



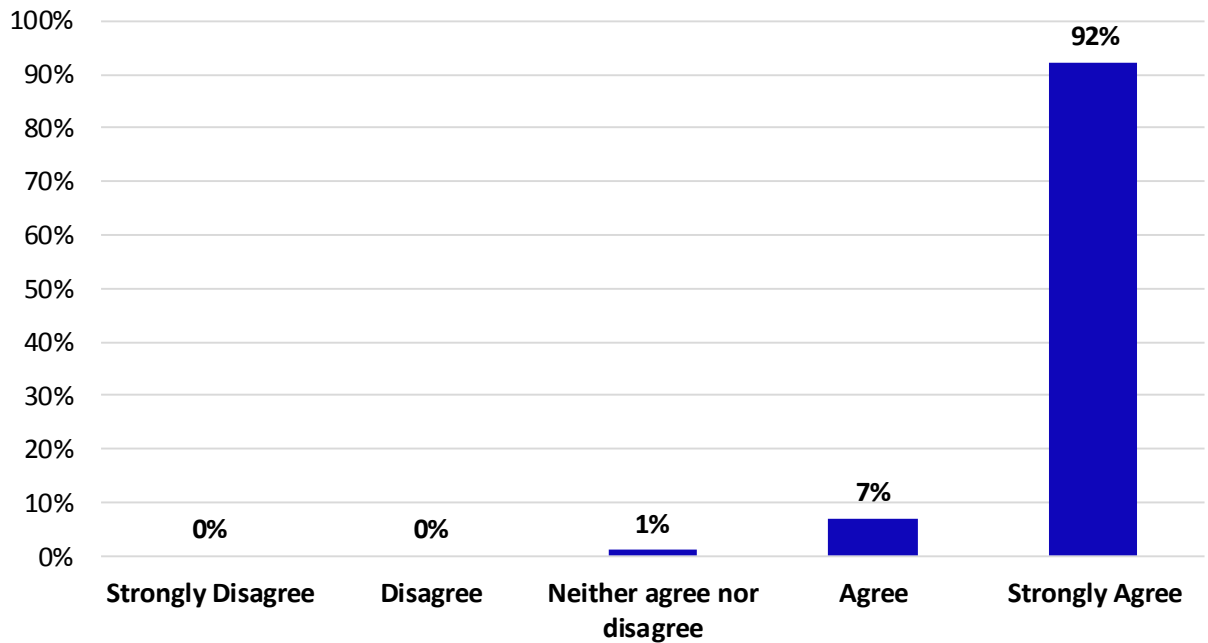

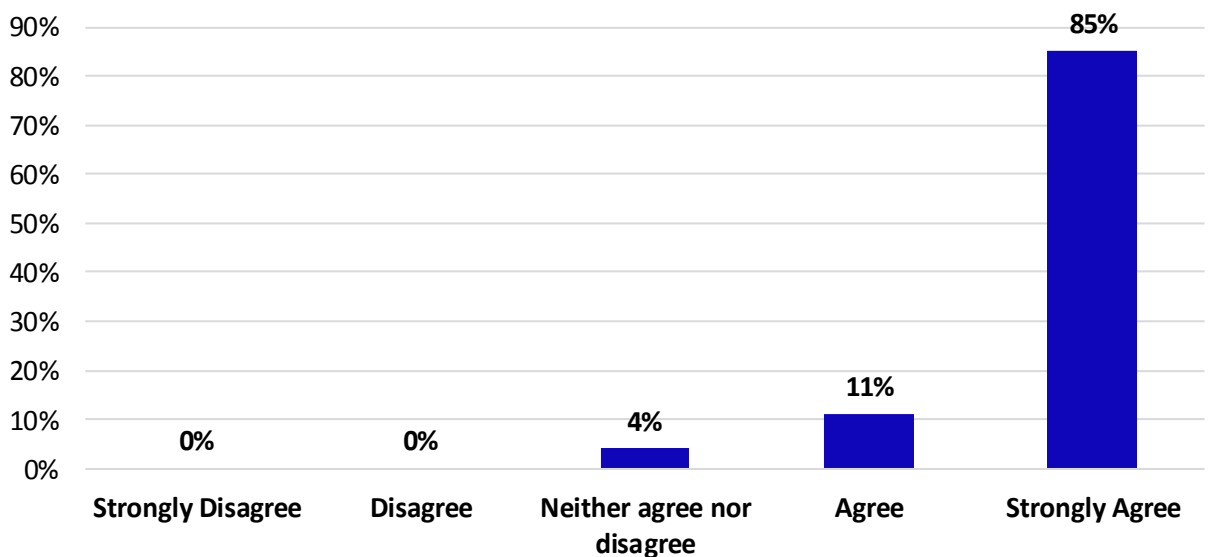

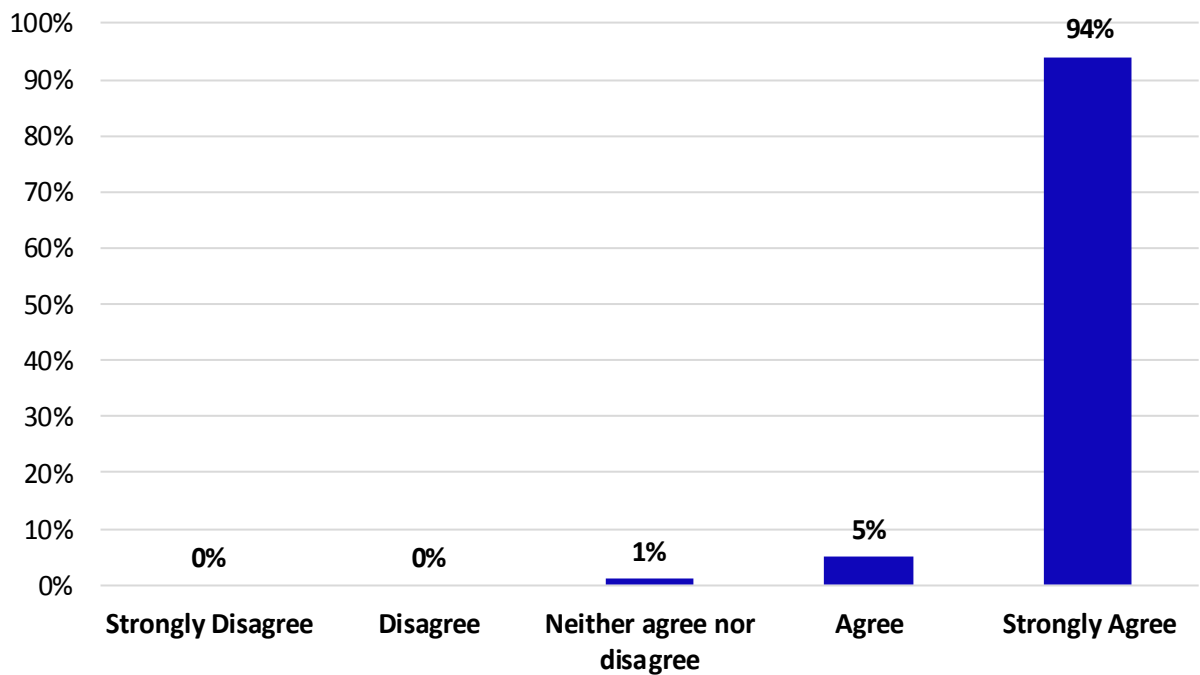

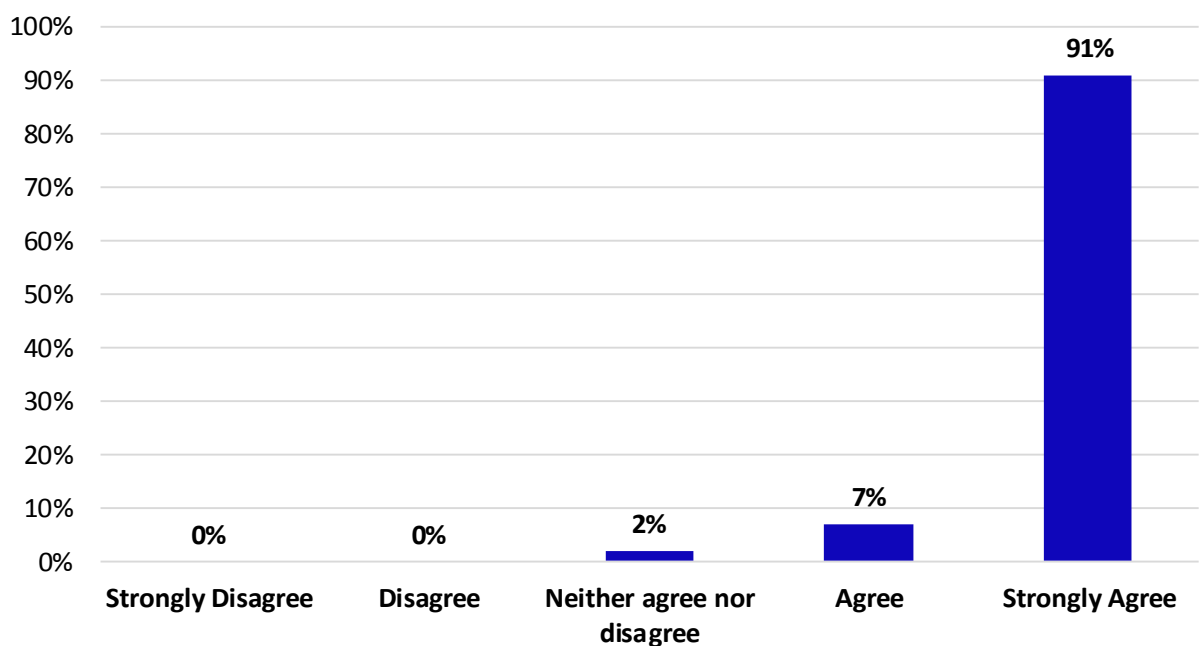

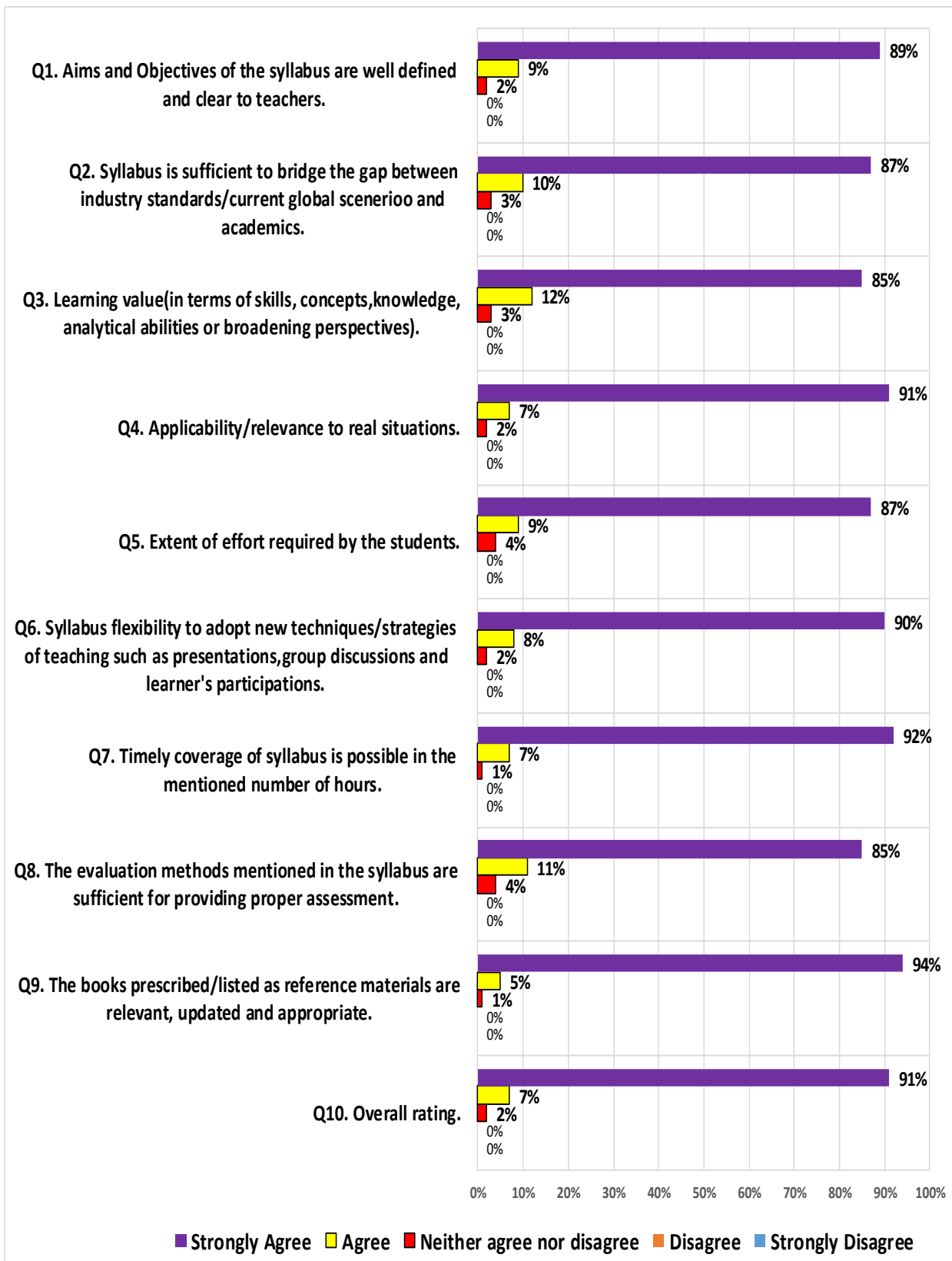

Overall Analysis

On the basis of the feedback obtained on different parameters, it was analysed that **98%** of teachers agreed and strongly agreed that the aims and objectives of the syllabus was well defined and clear. A total of **97%** of teachers agreed and strongly agreed that the syllabus is sufficient to bridge the gap between industry standards/current global scenarios and academics. In terms of skills, concepts, knowledge, analytical abilities or broadening perspectives, **97%** of teachers agreed and strongly agreed that the syllabus had learning values. Regarding applicability, **98%** agreed and strongly agreed that it had relevance to real life situations and **96%** stated that the syllabus was challenging enough that it required efforts by students to learn. With regard to flexibility, **98%** felt that the syllabus was flexible to adopt new technologies/strategies of teaching such as presentations, group discussions and learners' participations. Nearly **99%** stated that timely coverage of syllabus was possible in the mentioned number of hours. More than **96%** of teachers agreed that the evaluation methods mentioned in the syllabus was sufficient for providing proper assessment and **97%** strongly agreed that the books prescribed/listed as reference materials are relevant, updated and appropriate. Overall, **98%** agreed and strongly agreed that they are satisfied with the syllabus.

However, few notable suggestions received to enrich the syllabus from various colleges are as follows:

- Teachers suggested to introduce MBA in Hospital Management for students of Health Sciences.
- Teachers suggested to update the syllabus of Tax Laws, Security Laws.

Other than this, the teachers have been found, to be overall, satisfied with their curriculum.
