18.3 Ratification of the Online Proctored End Semester Examination session 2020-21.

In view of the safety and health of all the concerned in the situations owing to COVID-19 pandemic, the University conducted the Odd End-Semester for the second year onwards students of various programmes (except Medical & Dental) of the University in December 2020-January 2021 in online mode using Wheebox.

18.5 Ratification of the guidelines for the conduct of CTLD courses.

In view of the smooth conduct of the CTLD courses being offered as Value Added courses in various programmes of the University, the guidelines were framed and circulated with the approval of Vice Chancellor in anticipation of the approval of the Council. These guidelines are annexed here-with for consideration of the Council.

The highlights of the guidelines are given below:

- These are value-added courses, which are not linked to award of final diploma or degree of the University.
- b. On completion of all the CTLD courses, a certificate for 'Soft Skills for Professionalism' or 'Quantitative Aptitude Skill Enhancement' courses signed by Director CTLD and University Controller of Examination will be issued to qualifying student. This is applicable from batch 2019-20 and onwards.
- c. In case of programmes older than 2019-20, Director CTLD will issue certificates to qualifying students.
- d. CTLD courses shall be managed on ERP in the same way as other courses are being managed except that the marks of these courses shall not be included in the mark-sheet.
- e. Evaluation scheme of CTLD courses will be as given below:

18.6 Ratification of the TRAT-January cycle 2021 with revised mode and scheme of Entrance Examination in accordance with the UGC guidelines.

The Council was apprised about the action taken by the Vice Chancellor in anticipation of the approval of the Council, for including the interview as the component of PhD Entrance



Examination (TRAT) from January 2021 cycle, having weightage of 30 % and written test having weightage of 70%. The amendments were made in accordance with the provisions of the UGC (Minimum Standards and Procedures for the Award of M. Phil/PhD Degrees) Regulations, 2016 and 2nd Amendment UGC Regulations on PhD, Amendment 2018. The members had the consensus over the action taken by the Vice Chancellor as above.

18.7 Ratification of the cancellation of migration of student namely "Prafull Kumar", B.Tech (CE) admitted session 2019-20.

On the basis of request of the student namely "Prafull Kumar", B.Tech (Civil Engineering), admitted in session 2019-20 and the recommendation of the Principal-Faculty of Engineering, the Vice Chancellor approved the cancellation of migration of the above student as he wanted to continue his studies in the University in the same programme from the session 2020-21.

18.8 Ratification of the permission granted for Special Examination to "Shikha Singh", M.Sc. Medical (Anatomy).

"Shikha Singh", First year student of M.Sc. Medical Anatomy (admitted session 2019-20), failed in Theory and Practical exams of two courses i.e. Anatomy and Biochemistry. There was contradiction between the Study & Evaluation Scheme of the programme and provisions of the clause 9(a) (ii) & (iii) of the Ordinance governing the M.Sc. Medical Anatomy. As per the provisions of these clauses, the student failing in more than two courses could not be promoted to the next year of the programme and if a student fails in theory exam of the course, he/she shall have to appear in both the theory and practical exam of the same course or vice-versa. While in the Study-Evaluation scheme, the two courses Anatomy and Biochemistry were shown as four courses (two theory and two practical) which otherwise are only two courses with theory and practical exams. In view of these contradictions, the Vice Chancellor granted the permission to the student to appear in Supplementary Exam January 2021 on the recommended to make appropriate corrections in the programme study & evaluation scheme of the M.Sc. Medical Anatomy. In view of above, the Council ratified the action taken by the Vice Chancellor as above.

18.10 Ratification of the guidelines for conduct of Bridge courses in the programmes.

The concept of bridge courses was proposed to be introduced from the academic session 2020-21 with the objective of bridging the gap in knowledge required to successfully complete the specific porgramme of study for the students coming from diverse disciplines and admitted in the programmes or through lateral entry, so as to bring such students on the same level playing fields. In view of same, the guidelines were framed by the Expert Committee constituted for the purpose by the Vice Chancellor who then sanctioned approval to be adopted by the colleges/departments of the University (where-ever applicable) from the academic session 2020-21. The Committee also proposed to include the provision of bridge course in the Academic Ordinance of the University.

Following are the operational guidelines proposed by the Committee and approved by the Vice Chancellor:

- Bridge courses shall be kept as non-credit courses for students who take admission in the second year of the programme through lateral entry scheme like in Diploma in Engineering, B.Tech, B.Pharm etc.
- Similarly, Bridge course may also be offered for students who take admission in other such programmes where the students come from various diversified disciplines.
- iii. Students taking-up the bridge courses shall be required to qualify it during the lst year of their admissions. In case, if the student fails to qualify the bridge course even during the first year of admission then one special chance may be given with permission of the Vice Chancellor.
- iv. As Bridge course shall be a non-credit course, it shall not be included in the tabulation/statement of marks. Rather, a separate certificate shall be issued by the Controller of Examinations.
- v. Individual college/department shall design the course content and follow the evaluation scheme as given below:

vi. The pattern of question paper shall be as usual as in case of other courses.

The Vice Chancellor raised the concern in case of the action to be taken if a student fails to qualify the bridge course. The members discussed in detail and decided that bridge course should (if applicable) be qualified by the student to be eligible for award of the degree. The Council discussed and ratified the action taken by the Vice Chancellor as above.

RESOLVED THAT THE ACTION TAKEN BY THE VICE CHANCELLORAS ABOVE IS APPROVED. ALSO APPROVED TO MAKE THE BRIDGE COURSE (IF APPLICABLE) TO BE QUALIFIED AS A MANDATORY REQUIREMENT FOR THE AWARD OF DEGREE.

18.11 Ratification of introduction of PhD programme in Fine Arts from January 2021 Cycle.

The Council considered the action taken by the Vice Chancellor in anticipation of the approval of the Council, in sanctioning permission to commence PhD programme in Fine Arts from January 2021 cycle.

Due to the COVID-19 pandemic situations, the course MPED354 which being an educational tour based course, could not be scheduled during the 3rd semester session 2020-21 as per the Study and Evaluation scheme of the M.P.Ed. programme. As a one-time measure, the special permission was granted by the Vice Chancellor on the basis of the recommendation of the Programme-Incharge to schedule the Educational tour for the completion of the course MPED354 during the 4th semester session 2020-21. The Council ratified the action taken by the Vice Chancellor in anticipation of the approval of the Council, as above.
