#### Agenda 1: Proposal to start MBA (ABM) and M. Sc. (Agronomy) programs.

The first agenda of the meeting was regarding the initiation of MBA- Agri Business Management and M. Sc. (Agronomy) programs. The members of the committee applauded the decision. Hon'ble chairman Prof. D S Pandey invited comments from the experts on the agenda. Dr. Anupama Singh welcomed the decision. Also, she assured the committee to bestow her valuable opinion on formation of the courses of programs. However, she proposed to initiate M. Sc. # Agenda 2: Proposal for the approval of Experiential Learning Program (ELP) as per the recommendations of $V^{th}$ Dean Committee.

A proposal was made for the approval of Experiential Learning Program at college. The ELPs are in full swing at college. Presently, four EPLs are in practice - Production technology for Bioagents and Biofertilizer, Mushroom cultivation technology, Commercial Horticulture and Food Processing. Padam Shri Sh. Bharat Bhushan Tyagi suggested on implementing organic farming practices through ELP in trial fields for students. The experts and committee members imparted their valuable consent for the agenda as well. The agenda was approved in the meeting.
