





Following points were discussed & decision Made:

1. Principal, CLLS initiated the meeting with a warm welcome to Prof. A Makkar & Professor O P Tiwari and the new BOS members. The agenda of the meeting was to discuss the newly drafted syllabus.
2. BOS discussed the syllabus in detail and compared with the existing syllabus.
3. BOS suggested that Dissertation should be deleted from the curriculum as it is not suitable for UG students.
4. BOS suggested that courses of Constitution I & II, C.P.C. I & II, Cr.P.C. I & II and Labour Laws I & II should be in one academic session.
5. BOS suggested that procedural papers should not be taught in one part in a semester.




6. BOS suggested that case study (leading Cases) approach of teaching may be followed in class rooms by the teacher concerned.
7. BOS recommended that English language including Legal Language in three semesters is itself sufficient and it is not advisable to teach English as a subject in all 10 semesters and it is not practicable at all.
8. BOS approved the syllabus with above mentioned recommendations & with new marking scheme of 40 internals and 60 externals.
9. BOS also recommended that paper of Law of Taxation (LAW 803) in the running syllabus must be modified as the GST has been introduced and approved the modification in LAW 803 subject to the review by the BOS after implementation of GST in India.
10. BOS strongly recommended that in all running syllabus, teaching must be based on latest amendments.
