- 7. Board of Studies strongly recommended that in all running syllabus, teaching must be based on latest amendments. Concerned teachers will submit the proposal to the competent authorities for immediate amendment in the whole syllabus and the said authorities will commence the process of amendment as proposed by the concerned teachers.
