



❖ Assessment of Students' Performance and Scheme of Examination Pass Percentage & Promotional Criteria:

- English/Hindi shall be the medium of instruction and examination.
- Assessment of students' performance shall consist of: 60 marks (End Semester Written Examination) and 40 marks (Internal Assessment).
- The duration of the End Semester Written Examination in Core Courses and Elective Courses shall be three hours for 60 marks.
- For internal assessment of 40 marks, One internal Test of 1.5 Hour (20 Marks) + Assignment/Presentation/Viva shall be in the class in each course in each term. (Assignment- 10 Marks, Presentation/Viva- 10 Marks)
- Dissertation will carry 200 Marks. 150 For written Work and 50 for Viva

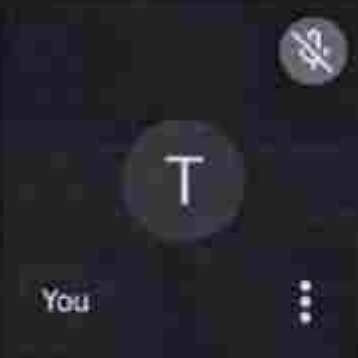
