## Points of discussion:

- Modified Master of Pharmacy (M. Pharm) Pharmaceutics and Pharmacology syllabus, prepared as per
  the guidance of Review committee, constituted by the University, was put before the Board of Studies
  and the same was recommended for approval by Academic council.
- COs/POs of all the courses under PG programs were reviewed and approved.
- An amendment was recommended in the ordinance regarding the special reappear of the exams which
  is stated as below-

A special reappear exam will be conducted for the Master of Pharmacy students having back paper in even and odd semester. It is recommended that odd semester back papers examination should be conducted within 45 days of the declaration of odd semester results and likewise for even semester.

- New CTLD courses of two (1+1) credits were also included in the M. Pharm (First & Second semester) syllabus. Now revised credits ranged from 102 to 107.
- The value-added courses (Total=04) mentioned in the table were reviewed and approved for Doctor of Pharmacy (Pharm. D). A new course under IKS theme, as value added course, mentioned in the table was reviewed and approved for Doctor of Pharmacy (Pharm. D).
- 6. Results of Master of Pharmacy and Doctor of Pharmacy were discussed and analysis was approved. However, the external member was of the following opinion:

### Points of discussion:

1. Course objectives of various courses in Bachelor of Pharmacy syllabus were reviewed, wherever necessary revised, and recommended. For first year, course objectives of all theory courses were made as per knowledge and comprehension level of Bloom's taxonomy. Besides the above, course objectives of BPHT-404 (Physical Pharmaceutics-I); BPHT-405 (Pharmacognosy & Phytochemistry-I) were made as per knowledge and comprehension level. An amendment was recommended in the ordinance regarding the special reappear of the term end exams as below-

A special reappear exam will be conducted for the students having back paper in even and odd semester. It is recommended that odd semester back papers examination should be conducted within 45 days of the declaration of odd semester results and likewise for even semester.

- New CTLD courses of two (1+1) credits were also included in the B. Pharm (Fifth & Sixth semester) syllabus. Now revised credits are 215.
- The value-added courses (Total=04) mentioned in the table were reviewed and recommended. A new
  course under IKS theme, as value added course, mentioned in the table was reviewed and
  recommended.

He was of the opinion that the TMCOP faculty should be involved in question paper setting/ moderation as well as result moderation before the result is made public.

In consideration of student advancement and enrichment, the BoS members recommend the above-mentioned points 1-4 for subsequent approval by Academic council. The BoS also recommended all the points for the subsequent approval through Academic Council. It is also recommended that the opinion of external expert may be considered and University regulations may be modified accordingly
