I. Previously approved syllabus of Master of Pharmacy (M. Pharm) - Pharmaceutics and Pharmacology was put before the Board of Studies. On the basis of feedback received from the M Pharm students and faculty members, the Board of studies decided to reduce the course contents of M Pharm IIIrd semester by removing total 05 credits of the following courses:

I. General elective courses (any one) in M Pharm IIIrd semester (GEC credit 03):

- MRM302T- Pharmacoeconomics
- MRM303T- Block chain technology in Pharmaceutical Industry
- MRM304T- Digital Therapeutics & Curative therapies
- MRM305T- Biosimilars

II. Discipline specific courses (any one) in M pharm IIIrd semester (DSEC Credit 02):

- MRM309T- Entrepreneurship Skill Development
- MRM310T- Intellectual Property Rights
- MRM311T- Business Model Innovation
- MRM312T- Principles of Management

M Pharm IIIrd semester consists of total 26 credits points having four compulsory courses (MRM301T, MRM306, MRM307, and MRM308) and two elective courses (GEC & DSEC). The Board of studies, after the deliberation, unanimously reached to the opinion that these courses (GEC & DSEC) were not as per Pharmacy Council of India (PCI) M Pharm Program regulation 2014 as in gazette of India no. 362 dated 11-12-2014. Some of the courses were repetitive and un-necessarily delaying the dissertation work of students due to high number of courses. In M Pharm IIIrd semester, after removing these courses with five credits, the total number of credits remain as (Table 1):

The minimum requirement to get the award of M Pharm degree, as per PCI M Pharm regulation 2014, is 95 credits points. The same was recommended for approval by Academic council.

- The subject contents (COs/POs), evaluation scheme, including of Master of Pharmacy Programme (Pharmaceutical Analysis & Pharmacognosy) were placed before the members of BOS and after careful deliberation, recommended for approval (annexure).
- COs/POs of all the courses under UG/PG programs were reviewed. Based on the recommendation of the external expert, Prof. Farhan Jalees, and other BoS members present, appropriate changes were made and incorporated in the latest copy attached with this report. Moreover, it was also observed that POs were not present in previously approved syllabus of M Pharm (Pharmaceutics) & M Pharm (Pharmacology), so in light of this, POs prepared, after prolonged deliberation, were included.
- Results of Diploma in Pharmacy, Bachelor of Pharmacy, Master of Pharmacy and Doctor of Pharmacy programs were discussed and result analysis was approved. However, the external member, Prof. Farhan Jalees, was of the opinion that TMCOP faculty should be involved in question paper setting and moderation, as well as, result moderation before the results are made public.
- The panel of examiners for academic session 2023-24 for B. Pharm Ist, IIIrd, Vth & VIIth Semesters; Pharm D (Ist to Vth) year and D. Pharm Ist and IInd year students were placed before the members of BOS to examine as per University ordinance laid down for College of Pharmacy and recommended for approval (annexure).
